From patient entry to owner insight

1. Trigger

A schedule or eligible product event starts a workflow run.

2. Scan

Clinizy Care finds eligible records and skips those that do not match the rules.

3. Dispatch

The configured message or task is sent through the selected channel.

4. Complete

The run records sent, skipped, and failed outcomes for review.

Implement around the real daily workflow

- Configure clinic branding, tax, services, doctors, schedules, and permissions.
- Train role groups on their real daily workflow before go-live.
- Review collections, queue, stock, access, and audit information after launch.
